Job Role:	Peripatetic Guitar Teacher

ROLE OVERVIEW

To provide individual and group guitar lessons to students, delivering high-quality instruction and preparing students for performances and exams.

RESPONSIBILITIES

- Provide high-quality guitar instruction to students, both individually and in groups
- Develop engaging and effective lesson plans tailored to the needs and abilities of each student
- Prepare students for performances, exams, and auditions, ensuring they are confident and wellprepared
- Offer constructive feedback and assess student progress regularly
- Manage scheduling, maintain records of student progress, and communicate with parents and school staff as needed
- Stay updated with the latest teaching methods and vocal techniques to continually improve the quality of instruction
- Work closely with school staff to support the overall music program

SKILLS, QUALIFICATIONS AND EXPERIENCE

- A well-qualified and professional musician who has experience teaching and performing a range of styles including the classical and electric guitar
- Ability to accompany students in lessons
- Experience helping students prepare for GCSE ensemble coursework
- Experience preparing and performing for regular scheduled concerts
- Ability to inspire and motivate students
- Ability to communicate effectively and to earn the respect of colleagues, students and parents
- Up to date knowledge of current examination requirements
